Due to the continued uncertainty created by the COVID-19 Delta variant, we are once again hosting our event online. CFACC serves vulnerable local children through one primary avenue, Court Appointed Special Advocate (CASA) volunteers of Cuyahoga County. This contraction was exacerbated by large federal funding cuts to crime victim programs like CASA. CASA volunteers serve and help to monitor the safety of children by visiting them in their foster homes, residential facilities, and schools, and advocate for them in court hearings.
