CASA Celebrates 10 Years of Advocating for Northeast Ohio Foster-System-Involved Youth, Expects to Reach 1,000 Total Children Served Court Appointed Special Advocates (CASAs) are volunteers who advocate for the best interests of vulnerable children in court and the community. CASA is a national child welfare initiative that began in Seattle, WA, in the late 1970s and has grown to include more than 900 individual CASA programs nationwide. CFACC was formed in 2016 as a not-for-profit organization to join the former Guardian ad Litem (GAL) Project with a new Court Appointed Special Advocate program, CASA of Cuyahoga County. While CFACC currently only supports CASA volunteers, they continue to work with GALs on certain types of cases. This dual representation model has been shown to enhance the quality of advocacy provided to foster-system-involved children and helps to expedite family permanency.

Since 2016, more than 250 CASA volunteers have positively impacted the lives of nearly 900 children in Cuyahoga County. Local CASA volunteers conduct independent investigations into a child's welfare and strive to provide the highest advocacy levels to child victims of abuse, neglect, and dependency while furthering collaborations with the Juvenile Court, Division of Children and Family Services, and other local child welfare providers.

Child and Family Advocates of Cuyahoga County is a non-profit 501(c)(3) charitable organization.


CASA VOLUNTEERS


